Draft Objectives Amendment

- 1. To engage in the production and the sale of electricity.
- 2. To engage in business concerning the sale, design, installment, development, system control, manufacture, purchase and delivery of any machinery and equipment relating to the manufacturing of energy, solar renewable energy and other renewable energies used in industry and commerce utility as well as all kinds of services relating to the aforementioned business.
- 3. To engage in business concerning the manufacture, sale, technology procurement, and service relating to electricity and all kinds of renewable energies used in industry, commerce and public utility as well as by-products and all kinds of related products.
- 4. To engage in business concerning the development, operation and construction of power plants and all kinds of renewable energies plants used in industry, commerce and public utility including by-products and related products as well as the power generator system and power supply of electricity and all kinds of renewable energies, the maintenance of all kind of power plants, including biomass power plants and RDF power plants, the construction and management of laboratory and other facilities in relation to the manufacture, sale, maintenance, purchase, transfer, giving, import and export of fuel and all kinds of energies used in industry, commerce and public utility as well as by-products and all kind of related products.
- 5. To engage in business in relation to, in connection with, or supporting the manufacture and sale of electricity and all kinds of renewable energies used in industry, commerce and public utility as well as by-products and all kind of related products including the exploration, research, development, manufacture, procurement, refinery, transformation, combination, packing, collecting, reservation, storage, importation, exportation, transportation, purchase and trade of electricity and all kinds of renewable energies used in industry, commerce and public utility as well as by-products and all kind of related products as well as products from other business that relates to or supports the aforementioned businesses.
- 6. To engage in business concerning the trade, importation, exportation, refinery, manufacture, sale, and transportation of petrol, lubricating oil, grease, gasoline, diesel, kerosene, fuel oil and other oils, liquid propane gas, liquidated natural gas (LNG), liquidated petroleum gas (LPG) fuel and all kinds of petrochemical products including byproducts and any related products as well as petrol and gas service stations, convenient

stores inside and outside of the stations and rendering of services for repair, maintenance, checking, lubricating, rust-proof spraying for all kinds of vehicles, including operating all types of factories that manufacture products in connection with the aforesaid businesses for example: machineries, tools, batteries, fuel oil and other fuels.

- 7. To engage in business concerning the management and consultant of energy, alternative energy, energy saving, renewable energy, clean energy and energy derived from different types of waste for the environment.
- 8. To engage in business concerning the recycling of plastics, or other similar goods in the state of raw material, or readymade products, waste removal factories, water treatment plants as well as the refinery and industrial separation of industrial waste or community's waste including the purchase, sale, transformation, cut, bury, separation of used material and waste to renew and/or compress said used material and waste for salvage in addition to the management of all types of wastes for the environment.
- 9. To engage in business concerning the manufacture, design, installment, sale, transportation, service, and system control of waste separating machines, RDF machines and all kinds of machineries related to the management of waste for the environment.
- 10. To engage in business concerning the manufacture, mixing, adjustment, separation, or means otherwise cause all kinds of fertilizer and related products and other products deriving from the use of remaining raw materials from the aforementioned businesses.
- 11. To engage in the sale, transportation, importation, exportation, network setting and installment all kinds of valves, pumps, regulator tools, spare parts, machineries and equipment used in all types of industrial plants and that related to the all kind of petroleum product, as well as the setting of quantity, volume and energy density measurement system.
- 12. To invest in any offshore businesses that have been prescribed in the objectives of the Company.
