The company had total revenue of 531.14 million baht, which is decreased from the same period last year by 33.35 million baht or 5.91%, mainly due to

- The NGV distribution station, Bangna branch, has been closed due to the expiration of the gas purchase agreement from PTT Public Company Limited.
- In 2022, Industrial pumps business group increasing revenue from sales from the company. PTT Public Company Limited by Baht 13.77 million and Cargill Siam Co., Ltd. by Baht 3.20 million , respectively.

Company net loss (Mother company) was 13.95 million baht, a decrease in loss from the same period last year amounted to 7.62 million baht or 120.38%, mainly due to

 The car park service business group has been opened for business in 2023, whose income is not related to costs and expenses incurred in the period. Most of them are direct costs.

 On April 6, 2023, the natural gas purchase agreement for Bangna branch expired.


Risk Management Policy
